- Celebrate each child's unique potential

Our Programs

Child Development Center

Our inclusive McWhorter Family Children's Center offers full time care and education to children with special needs alongside their typically developing peers ages six weeks to six years.

Pediatric Therapy

Pediatric Therapy at First Steps provides occupational, speech, physical, and feeding therapies to children with special needs in our McWhorter Family Children's Center.

Community Outreach Program

The First Steps Community Outreach Program supports families of children with disabilities or delays, age birth to three, in home-based and other community settings.



Personal Impact

Donna and her daughter Joy began their journey with the organization in the Fall of 2010 and both have remained valuable members of the First Steps family. Joy, a child with a brain injury resulting in cerebral palsy and cognitive impairments, was enrolled in the Child Development Center and received therapy services including physical, occupational, speech and feeding therapies.

Donna joined the world of parenting by adopting Joy as a single, full time working mother. Donna explains "... it was imperative to find a place like First Steps where she could be loved, nurtured, encouraged and also receive her necessary therapies." She also expressed her concerns as a mother to a child with special needs, she often worried about Joy being able to make friends in her environment. Seeing her peers become her companions and her family was truly priceless and an experience she looks back on fondly. Joy graduated



from First Steps in 2014 and is continuing to grow and thrive, building on the strong foundation she gained due to her time spent in such an inclusive program and the love and support of her mother.

With such a great personal experience and her passion for supporting children with differing needs, Donna joined the First Steps Therapy team as a Physical Therapist in 2017.

The life-changing and positive experiences she had with her very own daughter; she is now able to provide to so many in our community. She finds **joy** each day at First Steps now by watching her patients achieve new goals and grow into the best they can be. She watches friendships blossom, progress develop, and other children learn about their friends with special needs in open and welcoming environment.

Donna also witnesses the relief that the First Steps programs provide to parents and caretakers as they continue their journey with a family of resources and support. "First Steps made a huge impact on my & Joy's life together—I love that First Steps truly IS a family."
